## **COMMUNITY NEWS**

When the Covid-19 pandemic shut down the Early Bird Upstairs Meeting at the Fellowship Club in early 2020, Amy N immediately sprung into action. She created a Zoom online meeting space for the group which became the Early Bird Upstairs Zoom meeting or EBUZ. She also created a private Facebook page for the group. To join the Facebook page one needed a personal invite. The purpose of Facebook page was to inform, inspire, and allow communication between group members. With the help of Deb F and Danielle M the page became a valuable resource for the group. AA events and other activities were regularly posted. It became the "go to " source for information about local AA events, speaker meetings, and other AA news, including valuable workshops. From it's humble beginnings the EBUZ and Friends page has grown to 180 members. Every activity flyer from the District 8 Business meeting is scanned and posted to the page along with the the District 8 Newsletter, inspiring and educational videos, and recordings of our Super Sunday Speakers. If someone needs detailed information about an event or activity they simply have to visit the Facebook page. Because the Facebook page has proven to be so useful to EBUZ, the group has decided to make the page available to all AA members in the Cedar Rapids area and beyond. Although it is still a private group to protect the anonymity of its members any AA member in the area can join by searching for EBUZ and Friends on Facebook and asking to join.

## **WHAT TO GUBMIT?**

Q. What types of proposals, suggestions or ideas rise to the level of needing a General Service Conference "action" or "decision"?

A. Proposals that are important to the future of Alcoholics Anonymous, policy decisions or request for changes to Conference-approved literature and items that might require the collective conscience of the Fellowship.

## **HOW TO SUBMIT A PAI?**

GSRs have autonomy to do this any way you wish, but some shared experience....

- If there is a suggestion your group, district, or area feels strongly about....
- Craft the wording of the item
- Build supporting background information
- Get it submitted to the conference using the appropriate form
- Remember the September 15th Deadline.

## WHAT HAPPENS AFTER I GUBMIT A PAI?

- The Conference Coordinator acknowledges receipt of the proposed agenda item and lets the sender know which of the following options is most appropriate and, if necessary, an explanation of why and how the proposed agenda item is being directed.
- The Conference Coordinator at GSO sends the PAI to the GSO/GV staff to be reviewed then forwarded to the appropriate GSB Trustees Committee.
- 3. The Trustees Committee may refer the matter to the appropriate GS Conference Committee.

## <u>what happeng next?</u>

Next the Committee reviews, discusses and determines what to do with an item:

- Send it to the floor of the Conference (for vote)
- Refers to the appropriate Trustees Committee for consideration (or GSB) possible action
- Take no action.

These decisions become part of the Collective Conscience of AA in the US and Canada. This is Concept 1 (The final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.).
