There was considerable discussion about the Grapevine and it's finances. Publishing costs are going up and GSO is looking for ways to off set these costs. Julie shared and collected ideas ranging from discontinuing La Vina to adding donation nagware to the Grapevine podcasts and other online publications.

Cooperation with the Professional Community – Jeff B (cpc@aa-cedarrapids.org)

Hello District 8,

As CPC chair, it is my plan to put on a fall seminar for professionals in our District who come into contact with alcoholics. During this reporting period, I gathered information on the Cedar Rapids Public Library's meeting spaces, the process of reserving those spaces, and the restrictions on the use of those spaces.

The Cedar Rapids Public Library has several meeting spaces that are made available to the public and can be reserved up to 90 days in advance. The library has eight spaces available for use, including a conference room with capacity for six people and an auditorium with capacity for 200 people. Based on my review of the spaces, one half of the "Beems Auditorium" would best suit our needs. One-half of the Beems auditorium can seat 75 people auditorium style or 42 people seated at tables facing the presenter. A podium, sound system, projector, and kitchenette are also available for use.

In most circumstances the library does not charge a fee for use of its spaces. Based on my assessment, our intended use of the space would fall within the "free use" parameters. The CPC committee previously discussed providing food and beverage to attendees of the fall seminar. Based on the information I gathered, we would be required to: 1) prepare the food at home, 2) pay a \$2 per person fee to use an "outside caterer", or 3) use Roasters Coffeehouse located at the library to furnish food and beverage(s) for the event. I have reached out to Roasters Coffeehouse for information on catering.

Between now and the next District meeting, I plan to take the following actions:

- 1. Hold a CPC Committee meeting on Saturday, March 30 at 10:00 a.m., in the the Fellowship Club basement dining room, at which the following agenda items will be discussed (and hopefully resolved or firmed-up):
 - a. Date of the 2024 Fall CPC Seminar;
 - b. The 2024 Fall CPC Seminar schedule of speakers/events;
 - c. Proposed budget, including:
 - i. Literature;
 - Food/catering;
 - iii. Other.
 - d. A plan for how the CPC Committee will inform professionals in our District of the Fall CPC Seminar.

2. Prepare a report for the April District meeting with updates on the District 8 Fall 2024 CPC Seminar and prepare any motions that may be necessary to accomplish the same.
